Information to Registrars 2025-08-01 Implementation of ICANN's Registration Data Policy on .swiss

2024-07-02



This communication describes details of the implementation by the .swiss registry of the Registration Data Policy ("the Policy") published by ICANN on 21 February 2024 with an effective date of 21 August 2025. The ICANN Registration Data Policy can be found at

The transition phase started on 21 August 2024. The .swiss registry's full implementation will be effective from 1 August 2025, three weeks ahead of ICANN's deadline for implementation.

The main elements to be considered are the following:

- The .swiss TLD is not moving to the minimum Data Set and, therefore, Registrant Contact information will still be mandatory.
- Admin Contact is currently optional and will be moved to non-accepted from 1 August 2025, following the requirements set by ICANN in the Policy.
- Technical Contact is now optional and will remain optional.
- Billing Contact is now optional, but will not be accepted from 1 August 2025. This change derives from
 the recent GNSO Council decision to make this Contact non required. While this change is still awaiting
 ICANN's Board approval, we have already moved it into optional.
- In addition to the Registration Data Set, the .swiss TLD requires as mandatory the following field:
 Intended use. This field is not part of the Registration Data Set itself. Nevertheless, it is part of the additional Data that Registries are allowed to require, and, therefore, remains mandatory for all registrants.
- On the intended use field, and to clarify the status of this data point, it is not part of the escrow deposits, nor is published in the RDDS.

Note on Public ID:	Legal name of record under Public ID (UID or UPI) indicated in registrant contact record must match the registered name holder. If the Public ID is a UID, its Legal Name and the contact's Registrant Organization field must match. If the Public ID is a UPI, its Legal Name and the contact's Registrant Name field must match.
Note on Eligibility and Nexus:	Pre-validation and post-validation for compliance with community-based Eligibility and Nexus requirements.
